Interested persons should consult the individual hearing notices to determine the due date for written comments and the hearing procedures that will be used, The Board will hold a public hearing on February 14, 2019, at the City of Simi Valley Council Chambers, 2929 Tapo Canyon Road, Simi Valley, CA 93063. Interested persons are invited to attend. The Board will hear any testimony pertinent to the waste discharge and the tentative WDRs. Oral statements will be heard; however, for accuracy of the record, all important testimony should be in writing. The meeting which the hearing is a part will begin at 9:00 a.m.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next regularly scheduled meeting. That meeting will be held on March 14, 2019.
