NOTICE OF PUBLIC PARTICIPATION HEARINGS FOR SOUTHERN CALIFORNIA EDISON COMPANY'S GAS SERVICE FOR SANTA CATALINA ISLAND A.23-12-011

Why am I receiving this notice? Southern California Edison Company (SCE) and the California Public Utilities Commission (CPUC) would like to hear from you. You are invited to participate in a public forum regarding SCE's application to raise Catalina Gas rates and to begin the process to transition gas customers to all-electric service over a 20-year transition period. At the public forum, you can make comments and raise concerns with the CPUC's Administrative Law Judge who is overseeing this rate increase request.

How will the public forums be held? There will be two remote public forums as follows:

A quorum of commissioners may attend but no decisions will be made or voted on at these forums.

Why am I receiving this notice?

On December 15, 2023, SCE filed its application seeking authority to increase its revenues and rates for Santa Catalina Island Gas Operations (A.23-12-011) with the CPUC. The application is requesting a gas revenue of \$2.062 million in 2025, \$2.309 million in 2026, \$2.357 million in 2027, and \$2.402 million in 2028. This represents a total \$1.727 million revenue increase above present rate revenues over the 2025-2028 period. SCE also presents its plan to begin transitioning gas customers to all-electric service and proposed rate design changes.

Why is SCE requesting this rate increase?

SCE is requesting the rate increase to allow it to continue providing safe, reliable, and affordable gas service on Santa Catalina Island. SCE last filed a general rate case application with the CPUC in 2008. Since then, gas regulations and compliance requirements have substantially increased, resulting in increased costs. SCE claims increased revenues are needed to recover these increased costs.

Why is SCE requesting to begin the process to electrify gas customers?

SCE is requesting to initiate the process to electrify its gas service on Catalina based on forecasted customer savings, environmental and indoor air quality benefits, climate vulnerabilities, the high cost of service for a small gas customer base, and alignment with SCE's efforts to clean Catalina's long-term power generation mix. SCE plans to fully electrify the island over a period of 20-years or sooner, if feasible. SCE is not seeking cost recovery for electrification in this application.

How could this affect my monthly bill?

The following table compares the class average bill for different rate classes at current rates with the rates that would be in effect if SCE's rate request is approved by the CPUC. The class average consumption in the table is 13 therms/month for the G-1 class and 253 therms/month for the G-2 class.

How does the rest of the process work? This application has been assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SCE's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SCE's application. The Public Advocates Office is a party to the proceeding and is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels.
