PUBLIC NOTICE INTERIOR VEHICLE REGISTRATION

NOTICE IS HEREBY GIVEN that on October 1st, 2024 the **City of Avalon** begins its Annual Registration for all Interior Residential Vehicles, and will continue through November 1, 2024. Vehicle permits renewed after 4:30 p.m. November 1, 2023 shall be considered late, and will be required to pay a "late renewal charge" of \$30.00 per permit, in addition to the regular renewal fee of \$50.00.

If you wish to register a vehicle at this time you may drive it down to City Hall and bring proof of current vehicle registration. You must also be prepared to provide proof of Interior Residency.

INTERIOR PERMIT HOLDERS, WHO HAVE RELOCATED TO AVALON, ARE NOT ELIGIBLE TO RENEW THEIR INTERIOR VEHICLE PERMITS AND INTERIOR PERMITTED VEHICLES CANNOT PARK OVERNIGHT IN AVALON ON PUBLIC OR PRIVATE PROPERTY ON MORE THAN AN OCCASIONAL BASIS WITH A TEMPORARY PERMIT.

Registration for vehicles will be conducted at City Hall, 410 Avalon Canyon Rd, Monday through Friday between the hours of 8:00am-12:00pm

The fee for renewal is \$50.00 per permit. ALL PERMIT HOLDERS WITH OUTSTANDING TRAFFIC CITATIONS MUST TAKE CARE OF THESE OBLIGATIONS BEFORE RECEIVING THEIR STICKER. BRING PROOF OF CURRENT DMV REGISTRATION.

NOTICE OF PETITION TO ADMINISTER ESTATE OF JEANNE MAY NJOES

To all heirs, beneficiaries, creditors, contingent creditors, and persons who may otherwise be interested in the will or estate, or both, of JEANNE MAY NJOES

A PETITION FOR PROBATE has been filed by Gregory D. Njoes in the Superior Court of California, County of LOS ANGELES.

THE PETITION FOR PROBATE requests that Gregory D. Njoes be appointed as personal representative to administer the estate of the decedent. THE PETITION requests the decedent's lost will and codicils, if any, be admitted to probate. Copies of the lost will and any codicils are available for examination in the file kept by the court.

THE PETITION requests authority to administer the estate under the Independent Administration of Estates Act. (This authority will allow the personal representative to take many actions without obtaining court approval. Before taking certain very important actions, however, the personal representative will be required to give notice to interested persons unless they have waived notice or consented to the proposed action.) The independent administration authority will be granted unless an interested person files an objection to the petition and shows good cause why the court should not grant the authority.

A HEARING on the petition will be held on Nov. 20, 2024 at 8:30 AM in Dept. No. 5 located at 111 N. Hill St., Los Angeles, CA 90012.

IF YOU OBJECT to the granting of the petition, you should appear at the hearing and state your objections or file written objections with the court before the hearing. Your appearance may be in person or by your attorney. IF YOU ARE A CREDITOR or a contingent creditor of the decedent, you must file your claim with the court and mail a copy to the personal representative appointed by the court within the later of either (1) four months from the date of first issuance of letters to a general personal representative, as defined in section 58(b) of the California Probate Code, or (2) 60 days from the date of mailing or personal delivery to you of a notice under section 9052 of the California Probate Code.

Other California statutes and legal authority may affect your rights as a creditor. You may want to consult with an attorney knowledgeable in California law.

YOU MAY EXAMINE the file kept by the court. If you are a person interested in the estate, you may file with the court a Request for Special Notice (form DE-154) of the filing of an inventory and appraisal of estate assets or of any petition or account as provided in Probate Code section 1250. A Request for Special Notice form is available from the court clerk.
