NOTICE IS HEREBY GIVEN that the South Coast Air Quality Management District (South Coast AQMD) Hearing Board will hold a public hearing at 9:30 a.m. on **WEDNESDAY, MAY 27, 2026**, to receive a status report and/or consider a modification of the Order for Abatement issued by the Board on January 4, 2022 (modified and/or extended on 9/1/22, 1/24/23, 7/25/23, 1/25/24, 11/20/24, 5/27/25, 11/19/25) pertaining to **Rule 1470** against the **SOUTHERN CALIFORNIA EDISON (SCE), PEBBLY BEACH GENERATION STATION 1 Pebbly Beach Road, Avalon, CA 90704**, with regards to the operation of diesel Internal Combustion Engine (ICE) Unit No. 15, Selective Catalytic Reduction (SCR) System No. 15, and Carbon Monoxide (CO) Oxidation Catalyst, Unit No. 15.
